FUND OBJECTIVE

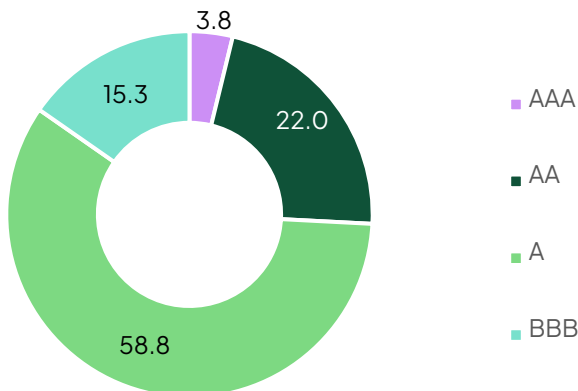
